## LICENCE TO TRADE IN ELECTRICITY AS AN ELECTRICITY TRADER

- The Central Electricity Regulatory Commission (hereinafter referred to as "the Commission"), in exercise of the powers conferred under Section 14 of the Electricity Act, 2003 (36 of 2003) (hereinafter referred to as "the Act"), hereby grants this licence as a Category "A" trader to Lanco Electric Utility Limited, (hereinafter referred to as "the licensee") to trade in electricity as an electricity trader in the whole of India, except the State of Jammu & Kashmir subject to the terms and conditions contained in the Act, (in particular, Sections 17 to 22 thereof, both inclusive), the Rules made by the Central Government (hereinafter referred to as "the Rules") and the Regulations specified by the Commission from time to time (hereinafter referred to as "the Regulations"), including statutory amendments, alterations, modifications, re-exactments thereof, which shall be read as part and parcel of this licence.
- The trading margin in the inter-state trading of electricity, fixed by the Commission, if considered necessary, shall apply to the licensee.
- This licence is not transferable, exceptin accordance with the provisions of the Act, the Rules and the Regulations
- 4. (1) The licensee shall not without prior approval of the Commission-
  - (a) undertake any transaction to acquire by prachase or take over or otherwise, the utility of any other licensee; or
  - (b) merge its utility light trainsy or any other lightness
  - (2) The licensee shall not acony time resign its ficence, or transfer its utility, or any part thereof, by sale, lease, exchange or otherwise without the prior approval of the Coalinission.
  - (3) Any agreement relating to any transaction referred to in sub-clause (1) and sub-clause (2) unless made with the approval of the commission, shall be void.
- 5. The grant of this licence to the licensee shall not in any way hinder or restrict the right of the Commission to grant a licence to any other person within the same area for trading in electricity as an electricity trader. The licensee shall not claim any exclusivity.
- This licence shall commence on the tate of its issue and unless revoked earlier, shall continue to be in force for a period of 25 (twenty live) years from the date of its issue.
- The licensee may with prior intimation to the Commission, engage in any business for optimum utilisation of its assets:
  - Provided that the licensee shall not engage in the business of transmission of electricity.
- Unless otherwise specified by the Commission, the licensee shall pay annual licence fee
  of Rs. one lakh, and licence fee for a part of the year shall be paid on pro rata basis,
  rounded off to the nearest hundred rupees.
  - For the purpose of this clause, the "year" means a period of twelve months from 1st April of a calendar year to 31st March of the following calendar year.
- The provisions contained in Sections 19 to 22, both inclusive, of the Act shall apply to the licensee with regard to revocation of license and sale of his utility.
- The licensee shall supply such information as may be called for by the Commission from time to time.

  - (3) Any agreement relating to any action referred in sub-clause (1) and sub-clause (2) unless made with the approval of the commission, shall be void.
- The grant of this licensee to the licensee shall not in any way hinder or restrict the 5. right of the Commission to grant a licence to any other person within the same area for trading in electricity as an electricity trader. The licensee shall not claim any exclusivity.

#### **NOTIFICATION**

In exercise of powers conferred under section 178 of the Electricity Act, 2003 (36 of 2003), and all other powers enabling it in this behalf, and after previous publication, the Central Electricity Regulatory Commission hereby makes the following regulations to amend the Central Electricity Regulatory Commission (Procedure, Terms and Conditions for grant of trading licence and other related matters) Regulations, 2009, ("hereinafter referred to as "the principal regulations"), namely:

- 1. **Short title and commencement.** (1) These regulations may be called the Central Electricity Regulatory Commission (Procedure, Terms and Conditions for grant of trading licence and other related matters) (First Amendment) Regulations, 2010.
- (2) These regulations shall come into force with effect from the date of their publication in the Official Gazette.
- 2. Amendment of Regulation 3 of principal regulations: Sub-clause (a) of clause (3) of Regulation 3 of the principal regulations shall be substituted as under, namely:

#### "(3) Capital adequacy and Liquidity Requirements

(a) Considering the volume of inter-State trading proposed to be undertaken, the net worth of the applicant for three years immediately preceding the year in which the application is made or such lesser period during which the applicant may have been incorporated, registered or formed and on the date of special balance sheet accompanying the application, shall not be less than the amounts specified hereunder:

## **ORDER**

Based on an application made under sub-section (1) of Section 15 of the Electricity Act, 2003 (the Act), Lanco Electric Utility Limited, Hyderabad ('the licensee'), the Commission on 23.7.2004 granted licence as a category `A` electricity trader for trading in whole of India, except the State of Jammu and Kashmir subject to the terms and conditions contained in the licence. Subsequently, on the request of licensee, the licence granted was upgraded as Category `F` vide letter dated 25.1.2006. Consequent to the notification of Central Electricity Regulatory Commission (Procedure, Terms and Conditions for grant of trading licence and other related matters) Regulations 2009, the Category `F` licence granted to the licensee was re-categorized

as Category 'I'. Subsequently, on the request of the licensee, Commission vide its order dated 5.1.2010 changed the name of the licensee from "LANCO Electric Utility Limited" to "LANCO Power Trading Limited".

- 2. The licensee vide its affidavit dated 11.10.2010 has informed that the name of the company has been changed from LANCO Power Trading Limited to National Energy Trading and Services Ltd. with effect from 2.9,2010. The certificate of change of name from the LANCO Power Trading Limited to National Energy Trading and Services Ltd. dated 2.9.2010 issued by Registrar of Companies, Andhra Pradesh has been placed on record along with the affidavit.
- 3. The affidavit dated 11.10.2010 has been treated as Miscellaneous Petition in terms of Regulations 3(3) of the Central Electricity Regulatory Commission (Payment of Fess) Regulations, 2008 and is being disposed of accordingly.
- 4. Consequent to issue of certificate by the Registrar of Companies, Andhra Pradesh, as noted above, we direct that in the Commission's records, name of the licensee be changed from "LANCO Power Trading Limited" to "National Energy Trading and Services Ltd." and an endorsement to that effect be made by Secretary of the Commission on the licence certificate issued in favour of the licensee. Except the name, there shall not be any change in the terms and conditions of the licence.

- 5. A copy of this order be sent to the Central Government in Ministry of Power and CEA for their information and record.
- 6. The licensee shall publish the notice in respect of the change of name of its company and address in leading newspapers and same shall also be uploaded in its website, for the information of all concerned.
